- h) To provide and institute awards, scholarships grants, stipends, pension to students of above discipline.
- i) To establish, maintain and manage research and development centres and reference library to promote general and technical education.
- j) To build, maintain and manage auditoriums, gymnasiums, health centres, playing fields, stadiums and community halls for the integrated and wholesome development of the general public.

- x) To create social public awareness among people in favour of Anti dowry, family welfare, adult and women education and literacy programme.

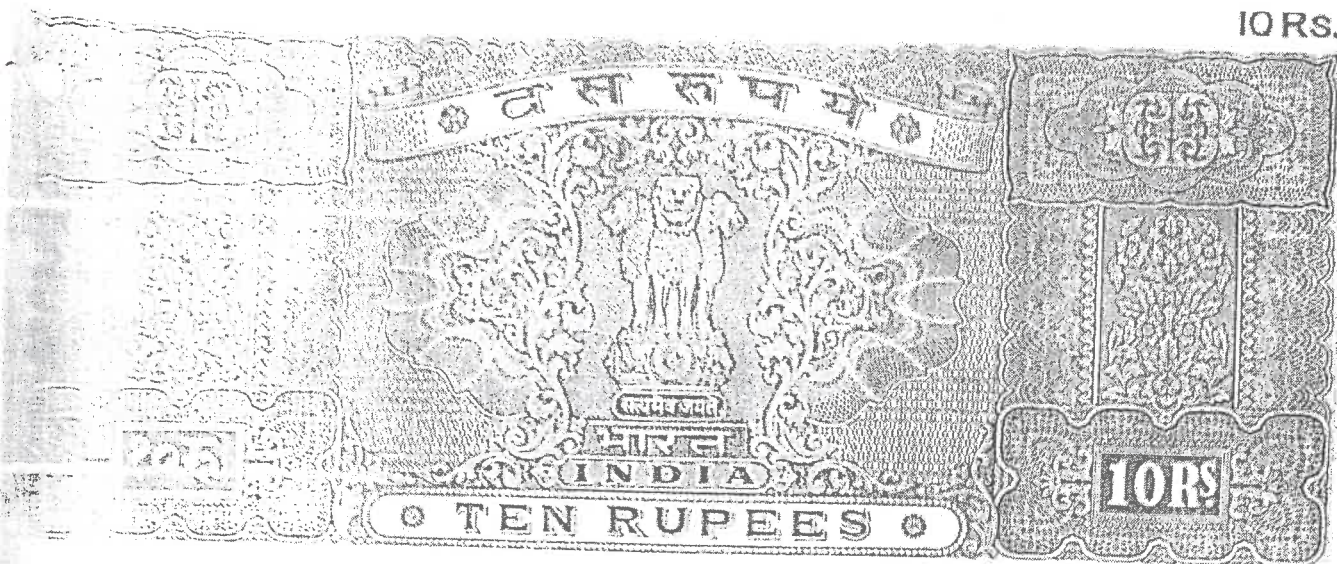

DONATION AND CONTRIBUTION

The trustees shall be entitled to receive upon such terms may think fit, subscriptions, donations in cash or kind including immovable properties and/or grants and/or other funds devices from the Central and State Governments and bequest from any person, institution, trust or corporate body and to collect funds by public or private appeals for carrying out the objects of the Trust.

POWERS OF THE TRUSTEES

In pursuance and fulfillment of the objects of the trust THE TRUSTEES may take all necessary steps and indulge in all such activities as are likely to promote the said objects directly or indirectly and to this and shall have all necessary powers including the following :-

- a) To manage the Trust properties and do all acts necessary for the preservation, maintenance, and management of the Trust and of the Trust property.
- b) The trustees will be at liberty to invest and keep invested the moneys, incomes and accretions of the income there of in such investments as the trustees in their absolute discretion shall think fit and proper.
- c) To acquire by purchase, gifts, lease, mortgage, sale, dispose of or otherwise with or without consideration, properties, movable or immovable for any more of the objects of the Trust.

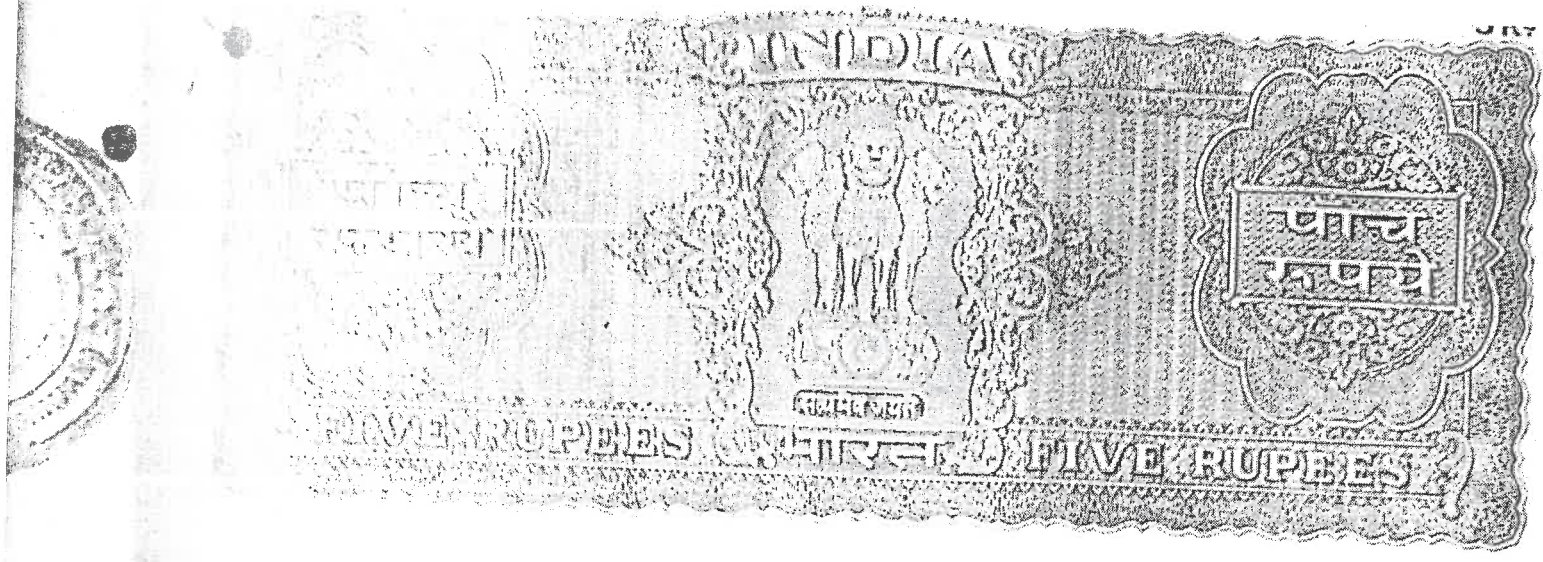
- a) To manage, lease, mortgage, sale, dispose off or otherwise deal with all or any part of the properties of the Trust, provided always that the mortgage lease or sale of any such assets or property of the Trust shall be in accordance with the rules and regulations and shall be for achieving the objects of the Trust.
- e) To purchase and otherwise acquire land by way of gift or otherwise and to build and maintain houses and homes and alter and improve the same and to provide all such houses and buildings with light, water drainage and other necessities.
- f) To borrow, with or without security or raise money in such manner and on such terms as may be necessary and good for achieving the objects of the Trust subject to previous approval of the Trustees.
- g) The trustees shall cause true and accurate accounts kept of all money received and spent and of all matters and things in respect thereof in course of management of Trust property or relating to the carrying out of the objects and purposes of the trust as well as of the assets, credits and effects of the Trust property.
- h) To compromise, compound, abandon, submit to arbitration or otherwise settle any debt account, claim or dispute whatsoever relating to the Trust property, or any part thereof.
- i) To delegate his or their powers or duties under the trust to co-trustees or any other person if found necessary in the course of the carrying out or performing of his or their duties.

To open and operate any account or accounts whether fixed or current or savings in the name of the Trust with any Scheduled Bank or banks and/or to close all or any such accounts or any of them as the Trustees may deem fit and proper. Any such account or accounts shall always be operated jointly by any two trustees or by two persons jointly. They shall be entitled in their discretion from time to time to start, discontinue, abolish and restart any aid, charity or charitable institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust property or income from any particular object or objects as nominated by the Board of Trustees.

To amalgamate this trust and the property with any other Trust or institution having objects incidental or similar to those of this trust, provided always that any such amalgamation is to be for the affected only. In the event of absolute necessity and subject to the consent of two-thirds of the Trustees for the time being and upon their certifying that such amalgamation was for the efficient functioning in furtherance of the objects of the Trust.

To appoint clerk, Manager or other employees for the management of the Trust property and/or to look after the affairs thereof and to delegate to them such duties or powers as the Trustees may think necessary.

- n) To nominate and appoint constituted attorneys or agents to delegate any of the duties and powers to such constituted attorneys or agents with regards to the management of the Trust property and all the matters and affairs relating to the purposes of the Trust and from collection of the rents and the profits and issue receipts of money, donations and fits without being responsible for the default of any such attorney or any agent
- o) To delegate any or more of its powers to persons, committies, bodies as may be deemed necessary for achieving the objects of the Trust and to make rules and regulations for regulating such committies, bodies and persons.
- p) To do all such deeds acts and things as are or may be deemed incidental or conducive to the attainment of or more of the objects or purposes of the Trust and exercise of any of the said powers provided that in case the Trustees shall take or hold any property which may be subject to any request, the Trustees shall only deal with or invest the same in such manner as allowed by law or by any court of law having regard to such request.
- q) To alter, modify and/or frame, schemes and rules and regulations for carrying out of the management and running of any institution or establishment run by the Trustees and for managing the affairs of the Trust and otherwise for giving effects to the objects and purposes of the Trust and to vary the same from time to time as the Trustees may in their absolute discretion think fair and proper.

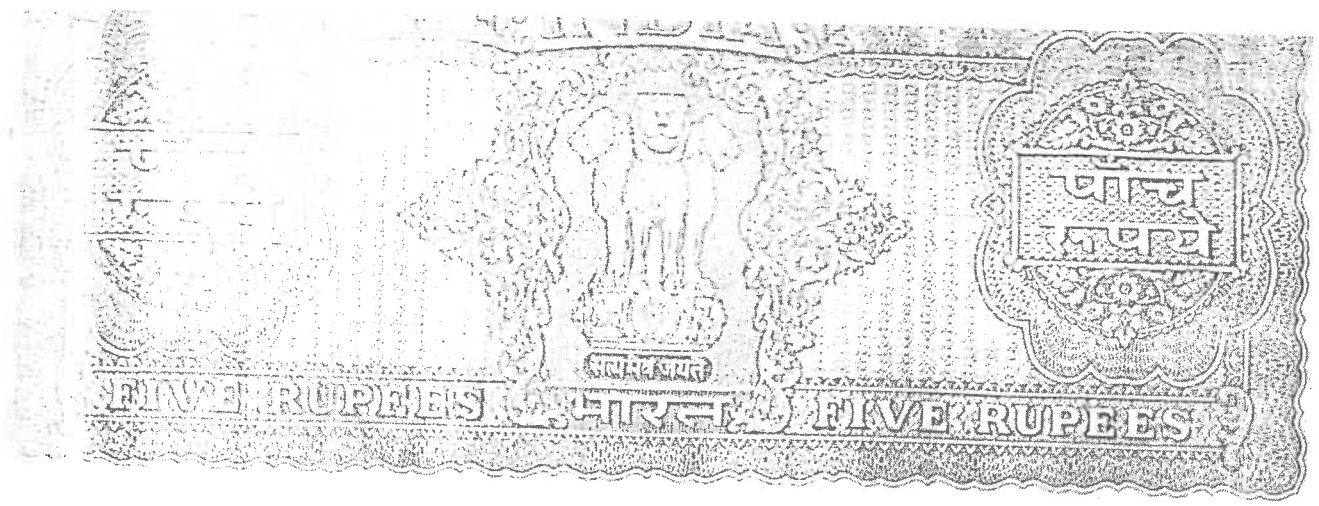

REMUNERATION OF TRUSTEE :

The Trustees shall not be entitled to receive any remuneration as Trustees, but they may reimburse themselves of all expenses actually incurred by them in connection with the Trust at their duties relating there in.

MANAGEMENT OF THE TRUST

- i. The power of appointing new trustees of these presents shall be exercised by the three-fourth majority of the Trustees present in the meeting.
- ii) The number of trustees shall not be less than Three and not more than twenty. In case the number of trustees falls below the required minimum number, the Board of Trustees will first fill up the vacancy of the Board as envisaged in sub-clause one of this clause.
- iii) It shall be lawful for life time of the Trustees to nominate any person or persons as special invites, though there may not be any vacancy in the office of the trustees.
- iv) The Trustee may constitute sub-committee to carry out the objectives of the trust and to regulate the same from time to time.
- v) To frame scheme, by-laws rules and regulations to conduct their meetings for appointment of chairman, secretary, transferor for carrying out the aims and objectives and for giving effects to the objectives and

purpose thereof and to vary, add to or modify, amend the same from time to time as the trustees in their discretion deem fit and proper.

(i) Any trustee may retire from the office on giving one month notice in writing to the other trustees or the chairman of the board of trustees of the intention to do so and such resignation shall take effect upon its acceptance by the other trustees.

(ii) The office of the trustee shall be vacated if he becomes lunatic or incapable of acting or as otherwise unfit to act, any member of the Board of Trustees may be removed or expelled from the trust by majority of the members of the trust present in the meeting if the conduct/action of such member is found contrary to the objectives, interest of the trust and the trust property.

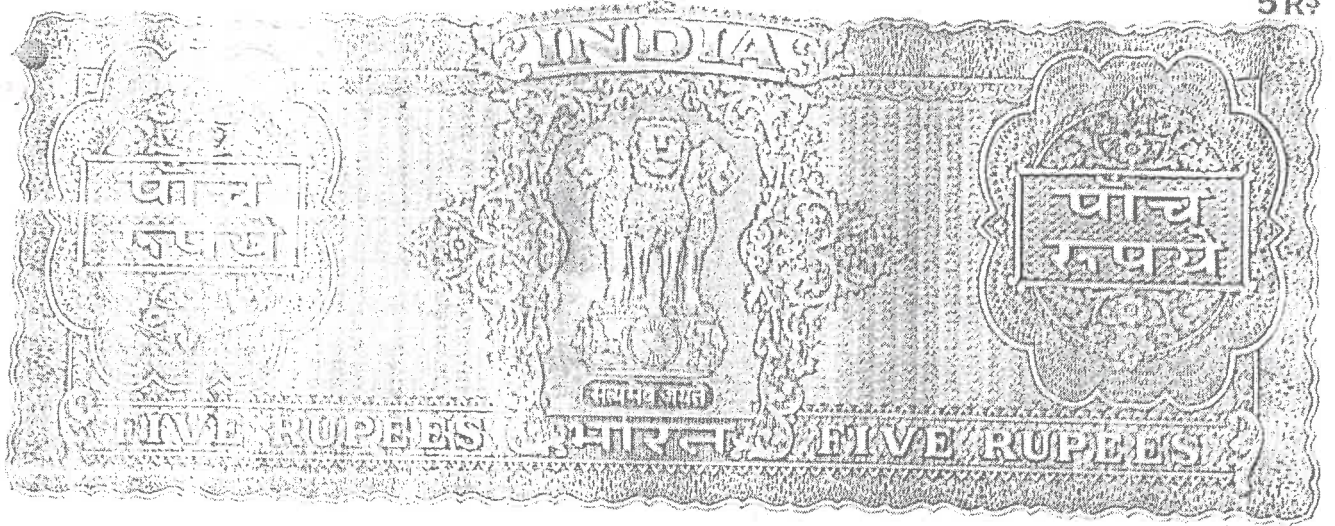
(iii) That in case of death, retirement, removal/vacation from office, expulsion from the Board of trust or otherwise, it shall be lawful for the remaining or surviving members of the board of trustees to appoint by writing a new trustee of trustees as the case may be in place of trustee or trustees as the case may be so dead, retired, vacated, removed, expelled, by a vote of two third majority of the members of the Board of trustees present in the meeting, and upon every such appointment the Trust property and funds shall with all convenient dispatch or being transferred or vested in the assets but every new trustee upon his appointment as aforesaid shall have same powers in the manner as if he had been originally appointed as a trustee under these presents.

PROCEDURE OF MEETINGS

- a) That unless and until altered, modified or amended according to the provisions contained in the trust deed, the following rules & regulations shall apply to the conduct of the business by the trustees and the meetings.
- b) The trustees shall elect by a simple majority one Chairman, one Secretary and one Treasurer out of the member of the Board of trust on such terms and conditions as they may decide.
- c) Three Trustees will form quorum.
- d) The Secretary of the Trust shall convene meeting of the board of Trustees.
- e) All matters arising at or dealt with at the meeting shall be decided by majority of votes and in case of equality of the chairman shall exercise his casting vote except the matters relation to sale or transfer mortgage of movable or immovable property belonging to the Trust removal or expulsion of a member of the Trust and appointment of view Trustee which shall be decided by view of two third majority of the member of the Board of Trust present in the meeting.
- f) The chairman shall preside over the meetings of the Board of Trust and in his absence the trustees present shall elect one of themselves to act as the chairman of such meetings.
- g) The Secretary shall be the representative or agent of the trust, shall act as the administrative head of the trust and shall represent the trust

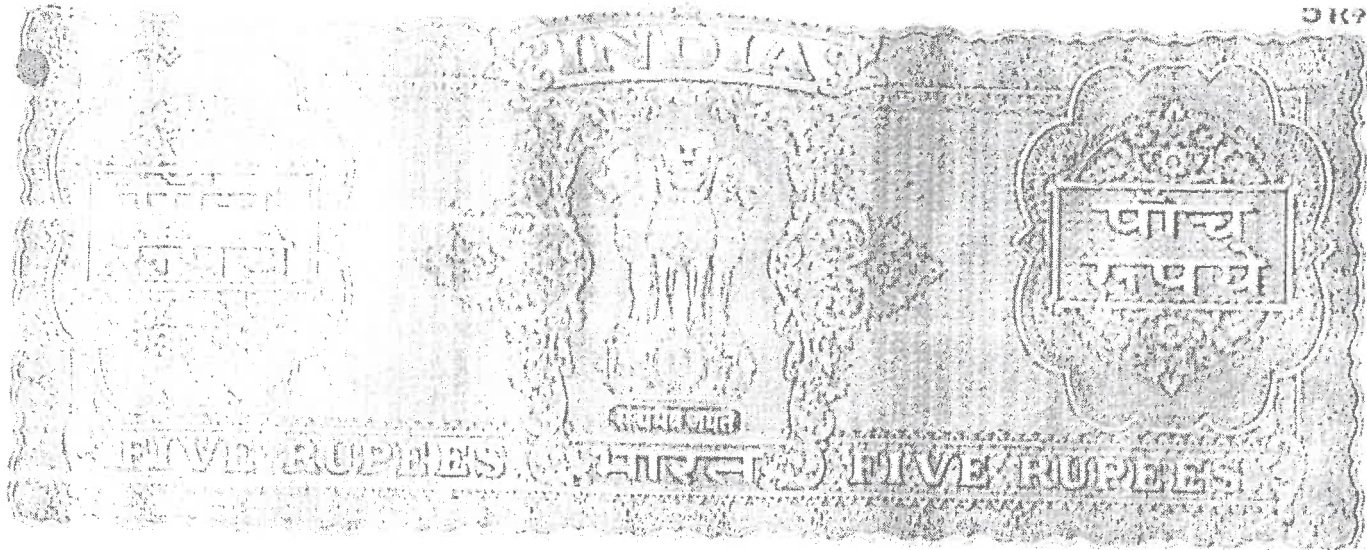

In all matters relating to the affairs of the trust and the trust fund.
b) A meeting of the trustees of which a quorum is present shall be competent to exercise and or any of the powers authorities and description vested in them by or under this deed or otherwise exercised by them.

REMOVAL

The Board of Trustees can remove any trustees, except Life Time Trustees in its duly called and held meeting by a vote of three - fourth majority of the total number of trustees for the time being of these presents.

General Clause

1. The Provisions of the Indian Trust Act, shall apply to this Trust , in case where this deed of trust does not make any express provision therefore.
2. Subject as aforesaid , the Trustees shall have powers from time to time to make and alter or amend the rules and regulations made with regard to the conduct of the business and all matters in respect of which any power or duty is hereby invested in them as they think proper.
3. If the Trust fails for any reason in the Trustees the net assets of the Trust both movable and immovable shall be handed over to any other Charitable Trust having the same objects of this Trust as may be decided by the majority of the Board of Trustees
